

Overview of Portability Provisions

As defined in Senate Bill 09-282, the entire DPSRS membership along with existing DPS hourly employees and all future DPS employees as of January 1, 2010, will be placed into a new PERA division to be known as the DPS division. While DPSRS will not exist after January 1, 2010, your service and account balance will remain intact under the DPSRS benefit structure. To distinguish this benefit structure from any of the structures currently offered by PERA, it is referred to in this fact sheet as the DPSRS benefit structure.

This fact sheet outlines the portability provisions as defined in Senate Bill 09-282, which impacts members moving between the PERA DPS Division and other PERA Divisions.

The provisions of Senate Bill 09-282 provide that DPSRS active and inactive members and DPSRS retirees with accounts at PERA may have the ability to make a choice to accrue a PERA benefit or continue to build a benefit based on their current DPSRS benefit structure. The following scenarios in this fact sheet outline when this choice would be triggered for you.

Portability Rules

Regardless of your membership status, the following rules apply to portability:

- The election option to decide which benefit to build is a one-time irrevocable decision.
- Only one benefit may be accrued on or after the merger date of January 1, 2010.
- The benefit not elected will be frozen but will earn regular interest at the rate set by PERA.
- Portability does not combine service credit.
- If no election is made by the member within 60 calendar days of the date the choice is triggered, the default will be with the benefit structure with the greatest amount of service credit.

PERA Members Without a DPSRS Account

If you are a PERA member without an account at DPSRS, these portability provisions do not apply to you. On or after January 1, 2010, DPS and DPS charter schools will be PERA-affiliated employers and you can continue to build on your PERA benefit should you decide to pursue employment at DPS or a DPS charter school.
